

AN ORDINANCE LEVING A TAX RATE FOR MORRIS COUNTY FOR THE TAX YEAR 2023

COUNTY CLERK MORRIS COUNTY, TX

BE IT ORDAINED AND ORDERED by the Commissioner's Court of MORRIS COUNTY

WE, the Commissioner's Court of MORRIS COUNTY do hereby levy or adopt the tax rate on each \$100.00 worth of property located within MORRIS COUNTY made taxable by law, for tax year 2023 as follows:

General Fund..... \$317204
Road & Bridge..... \$107309
TOTAL TAX RATE... \$424513

THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE. THE TAX RATE WILL EFFECTIVELY BE RAISED BY 7.6 PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS OF A \$100,000 HOME BY APPROXIMATELY \$27.24.

WHEREAS, these funds are necessary and appropriate for the funding of the 2023-2024 Morris County budget, and
WHEREAS, said budget has been heretofore regularly adopted by the Commissioner's Court of Morris County, and
WHEREAS, all other things required by law to be done have been done properly by the appropriate officials, now therefore
IT IS HEREBY RESOLVED, by affirmative vote of the Commissioner's Court of Morris County, Texas at a regular meeting held in the Commissioner's Courtroom of the County of Morris the 31st day of August 2023.

PASSED, ADOPTED and APPROVED this day.

THIS RATE WILL RAISE MORE REVENUE FROM PROPERTY TAXES THAN LAST YEAR'S BUDGET BY AN AMOUNT OF \$321,988 WHICH IS A 8.24 PERCENT INCREASE FROM LAST YEAR'S BUDGET. THE PROPERTY TAX REVENUE TO BE RAISED FROM NEW PROPERTY ADDED TO THE TAX ROLL THIS YEAR IS \$47,686.00

THE CHIEF APPRAISER is hereby authorized to assess and collect the taxes of MORRIS COUNTY.

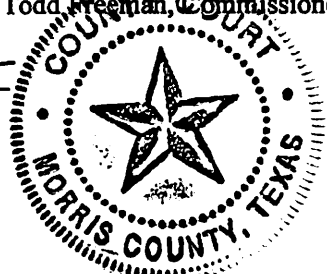
